ON THE SUBJECT OF DEATH

Many people in the romantic era believed that man should become one with nature. They felt power and wisdom comes from nature. They also believed in humanism, which elevated common man. Intuition was said to be more important than reason. People stressed the idea of following instincts. "Thanatopsis" is a good example of romantic literature by displaying the elements of man becoming one with nature and humanism ideals.


First of all, the poem shows several examples of how man should become one with nature... even in death.



A FIRE-SIDE POET

The beauty of "Thanatopsis" language and the grandeur of its images immediately established William Cullen Bryant's literary reputation and helped create pride in the ability of American writers to equal the literary creations of the British Romantic poets.

He was one of the Fireside Poets, a group of 19th-century American Romantic poets, mostly from New England. They were called so because their poems were typically read around a fire for the family to enjoy.



LITERARY ELEMENTS

Blank Verse

Blank verse is unrhymed poetry written in iambic pentameter. An iambic pentameter line consists of five metric units, or feet, with two syllables each. The first is weakly stressed, and the second is strongly stressed.

Elaboration

Refers to a writing technique in which a subject is introduced and then expanded on through repetition with minor changes, the addition of details, or similar methods.





APPLY READING SKILL

Paraphrase

Paraphrasing, or rewriting passages in one's own words, helps students by reinforcing their understanding of a literary work. Remind students that when they paraphrase, they should change the words and sentence structure as appropriate but retain the ideas of the original.
